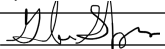

All In Energy is a nonprofit organization that enables underserved residents (historically renters, low-to-moderate income households, people who speak languages other than English, and people of color) to save money on their utility bills by connecting them to government and utility energy efficiency and renewable energy programs. We also serve as a talent pipeline, expanding clean energy job opportunities for individuals in the communities we serve through a paid, hands-on training program.

hard to build a board of directors that is comprised of individuals diverse in gender and race, as well as areas of expertise. We set a goal of recruiting a board of directors that is 50% people of color and 50% female. The six board members we had in 2018 were 60% female (including one board member who identifies as a transgender female) and 40% people of color. One member represents the Codman Square community where we have piloted our efforts. Born in Ecuador, he is a native Spanish speaker. Our burgeoning Advisory Board consists of one African American male and one African American female. We have not yet asked our board to submit their age or income levels. Our staff consisted of paid, seasonal interns, of which we have hired six. We actively worked to recruit racially and linguistically diverse candidates for our application processes. We hired from a variety of institutions in and around Boston, including community colleges. Our interns have studied at Bentley, Boston University, Brandeis, Bunker Hill Community College, Northeastern. We have also used our job descriptions and interview questions to emphasize the value of previous experience working in underserved communities, as well as multilingual abilities. Our interns in 2018 were 83% female, 67% people of color and 67% fluently spoke a language other than English. Though most of our interns remain in school, 50% of them have already taken on next step internships or jobs in the clean energy sector.
