All In Energy is a nonprofit organization that enables underserved residents (historically renters, low-to-moderate income households, people who speak languages other than English, and people of color) to save money on their utility bills by connecting them to government and utility energy efficiency and renewable energy programs. We also serve as a talent pipeline, expanding clean energy job opportunities for individuals in the communities we serve through a paid, hands-on training program.

In 2019 we continued our work in Dorchester, and expanded our reach in Boston to Roxbury and Mattapan. In addition to partnering with the Codman Square Neighborhood Development Corporation, we secured a partnership with the Mattapan Neighborhood Council. We established relationships with retail locations to set up a tabling presence. In addition, we tabled at community events throughout the City. We had a presence at 60 events in the City of Boston. We set direct mail letters to 150 addresses and knocked on nearly 1,000 doors in the Codman Square neighborhood. In all, we engaged 446 in Boston residents in 2019 and our work resulted in 96 audits being completed leading to 23 Wx jobs. We also made 92 referrals to low-income and Multi-family program

City of Cambridge: Our Cambridge program in 2019 was focused on delivering energy assessments to renter occupied units. In partnership with a certified Mass Save home performance contractor, we hired a multi-lingual rental property energy advisor to complete these assessments. To reach these renters, we tabled at about 20 Cambridge community events. We also tabled at several retail locations and City buildings (libraries, community centers, etc.) across the City as we will be attending the Winter Farmers Market at the Cambridge Community Center this winter season and are working to build more retail relationships around the city. Events generated 39 of our 102 scheduled and completed assessments. We launched a small canvassing team. We mailed letters to 2,025 residents in census tracts 3526, 3525, 3527, and 3528. These tracts correlate roughly the Wellington-Harrington neighborhood and the northern section of the Port neighborhood. We chose these areas to start because the assessors data indicated a high volume of renters in this small geography, with roughly 62% of the units in 1-4 buildings being rental units. The canvassing team completed about 100 hours of canvassing and has knocked 1,460 doors. This has produced 63 of our 102 scheduled or completed assessments. In all, We completed 67 assessments for renters in Cambridge. On average, we

Workforce development program: Since our founding, through our workforce development, we have: Provided internship positions for 14 individuals. All have been paid or received college credit. 8 of these interns have gotten their next job in the industry. We had our first intern graduate from college and get a job in industry (Camille McDaniel at Acadia Center) Our interns have been 64% women, 64% people of color and 57% bi/multilingual. We've worked with the MassCEC internship program, tried out College for Social Innovation in Fall, and are now working with BHCC to get interns through their Learn and Earn Program.
