All In Energy is a nonprofit organization that enables underserved residents (historically renters, low-to-moderate income households, people who speak languages other than English, and people of color) to save money on their utility bills by connecting them to government and utility energy efficiency and renewable energy programs. We also serve as a talent pipeline, expanding clean energy job opportunities for individuals in the communities we serve through a paid, hands-on training experience.

In 2021, we continued our partnerships with the City of Cambridge, Lawrence, Methuen and Neighborhood of Dorchester, but also expanded our bilingual outreach campaigns to the Cities of Haverhill, Andover, Framingham, and Chelsea. In these communities, by the end of 2021, we had connected 2,071 residents to energy efficiency programs. At least 1,045 residents had completed no-cost energy assessments; and 438 households had chosen to move forward with weatherization upgrades. Engaged families are estimated to be saving over 1 million per year on energy use. Outreach Campaigns continued to use co-branded letters, fliers, banners, ads, radio/T.V. appearances with multiple municipalities and community organizations. All In Energy also launched its Energy Bill Check Up service, where we review resident's energy bills to help them move off harmful third party energy suppliers, switch to the residential assistance rate program, and get onto debt forgiveness or payment plans. All In Energy is conscientiously working to build an organization that is diverse (starting with gender, race, and languages spoken), inclusive in culture, and equitable in practices. In 2021, All In Energy's team consisted of six full-time and four part-time employees, and two interns from the College for Social Innovation's Semester in the City program. More than 50% of All In Energy's staff are people of color and 58% are women. Additionally, All In Energy's 2021 board of directors was 50% people of color and 50% female.
