In 2024, All In Energy continued to lead the Mass Save Community First Partnership, operating in over 50 municipalities across Massachusetts, including Boston, Lawrence, Chelsea, Framingham, and other Environmental Justice (EJ) communities. Through these partnerships with municipalities and community-based organizations, All In Energy helped thousands of residents access no-cost home energy assessments, insulation, and heating and cooling upgrades, collectively saving families millions of dollars on energy bills while reducing greenhouse gas emissions. All In Energy opened a new office in Lawrence, creating a local hub for our bilingual Customer Action Team and expanding in-person support for residents in the Merrimack Valley. The hybrid team of English, Spanish, and Portuguese-speaking staff provided one-on-one assistance to help residents schedule energy assessments, navigate utility programs, and access additional energy assistance resources. All In Energy launched its pilot Energy Workforce Training Program with support from the MassCEC Equity Workforce Grant, preparing bilingual customer service representatives for careers as energy auditors. This initiative aims to build pathways for underrepresented workers into technical clean energy roles, addressing industry-wide diversity and inclusion gaps. Throughout 2024, All In Energy continued offering our Energy Bill
